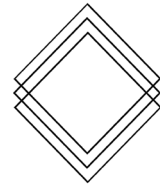




## Wills and Lasting Power of Attorney

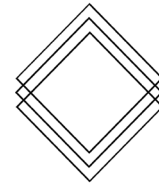

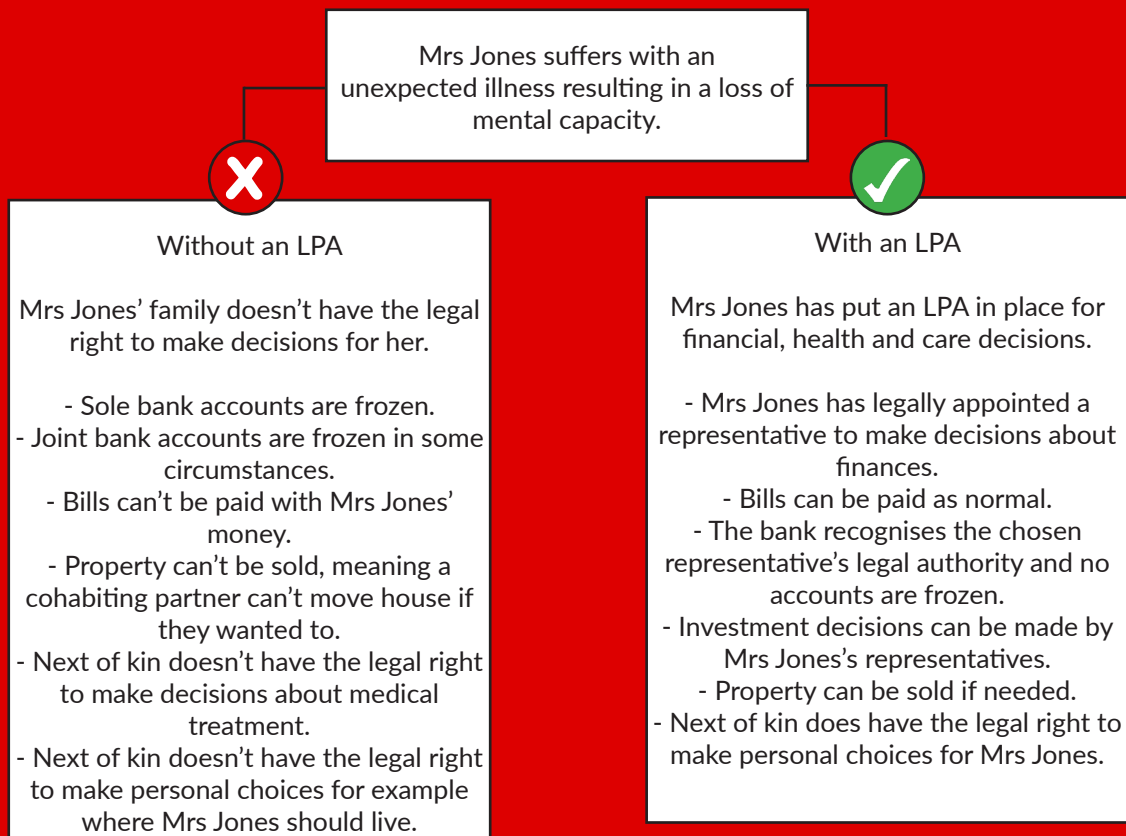

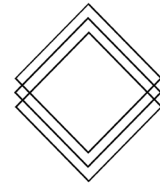
## What is a Lasting Power of Attorney?

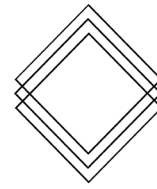

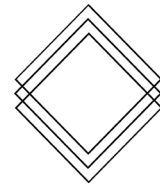

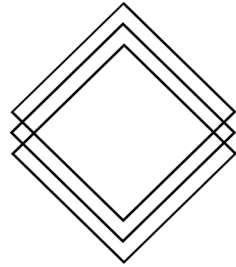
